

New Federal Requirement* Renovator Certification

*(40 CFR 745) As of April 22, 2010, with some exceptions, renovations conducted for compensation in pre-1978 housing or child occupied facilities must be performed by Certified Firms using Certified Renovators. To become a Certified Renovator requires taking a one day RRP class from an EPA accredited training provider such as Chem Scope Inc. Classes are at 8 Moulthrop St, No. Haven CT.

Frequently asked questions to the EPA's new RRP rule (40 CFR Part 745)

- 1.) ***Who needs EPA Certified Renovator Training?*** In short, anyone who is being compensated for work that disturbs painted surfaces in homes or child occupied facilities (which can include schools) built before 1978 and where windows replaced or more than 6 square feet of interior paint in any one room or 20 square feet of paint on exterior surfaces will be disturbed by renovations and the component to be disturbed has not been proven to be lead free.
- 2.) ***How do I get certified?*** You need to take an 8 hour class from an EPA accredited training provider that includes both hands-on proficiency testing and a written exam.
- 3.) ***How long is the certification good for?*** Recertification will need to be done every 5 years.
- 4.) ***Does every employee need to be certified?*** By and large there only needs to be one Certified Renovator on each job. As part of the course the students will learn how they can train others on the job to perform certain specific tasks.
- 5.) ***Is it the company or the individual that needs to be certified?*** Both. Jobs that fall under this rule will need to have the work done by an EPA certified renovator working for an EPA certified renovation firm.
- 6.) ***What penalties might a contractor face for non-compliance?*** The penalties can be in excess of \$32,500 per violation per day. This affects remodelers, plumbers, electricians, painters, window replacement and any trade that is involved in the renovation of these older properties.
- 7.) ***What if I already have some Lead Training, do I need this course?*** Those who have taken lead abatement supervisor, HUD Lead Safe and certain other courses may become Certified Renovators by taking a 4 hour Refresher RRP Course (instead of the 8 hour initial training). - 8.) ***We only work in commercial buildings. Does the rule apply to us?*** Not now, as long as they are not pre-1978 child occupied facilities and have no housing in them. By 2013, EPA must consider RRP regulations for commercial buildings.
